Dear Sir,

1. With reference to Office of Election Commission (2023-25) HQ, MES BUILDERS ASSOCIATION OF INDIA (Regd.) letter nos MBAI/Election/02/2023-2025 Date: 02 May 2023, MBAI/Election/03/2023-2025 Date: 02 May 2023 , MBAI/Election/04/2023-2025 Date: 02 May 2023 and MBAI/Election/ 114 /2023 -2025 Date: 3rd June, 2023 (Available on HQ MES BAI website www.mesbai.co.in).
2. It is informed to all the esteemed members of the Branch that as per the decision of the Executive Committee of Branch held on 02.06.2023 at Dee Mark Hotel & Resorts, Delhi-110037. I Narender Kumar have been elected as the Election Chairman to conduct the Bi-Ennial Election of Branch for the Term 2023-2025. The same will be held on 28th June 2023 (Wednesday) from 9:00 AM to 4 PM & venue for the election is 106 Kirti deep, Building, Nangal Raya. The Branch Elections will be held as per provisions defined in MOA Para 11 through filing of nomination forms.
3. Annual Subscription and other Branch dues has to be paid by 18th June 2023 by Cheque or by NEFT/RTGS/ONLINE/UPI/CASH by 20th June 2023 by any Member who is Desirous to contest the Branch Election. Members who had deposited the subscription by the above dates shall only be eligible to contest the Election.
4. Members who have paid all their Dues by 02 days before the Election Day ie by 26th June 2023 will have Voting rights in the branch Elections.
5. Only the enlisted contractors whose names are being figured in the original valid documents issued by the MES Enlisting Authorities would be eligible to contest/ participate in the elections. In case of Partnership Co. or Limited Co. only one person of the company can contest the branch election and voting right shall also be for one person only. Incase of Proprietorship only Proprietor is authorized to contest/vote. Therefore, the members are requested to submit their valid latest enlistment/ re-enlistment copies issued by the MES Deptt. before OR up to 20th June 2023 in the Association Office to make them eligible for contesting Election/Voting.
6. Eligible criteria for the post of Branch Chairman and Hony Secretary must have served 04 (Four) calendar years to tenures of any post of all the executive committees of branch.
7. Only enlisted contractors shall have right to contest/vote but Associate members will not be having any right to contest/vote. A newly enrolled member will not be eligible to contest elections for any post of branch for the period of two years from the date of enrolment by the Head Quarter.


8. As per letter No MESBAI/Election/12/2023-25 dated 16.05.2023 from Chief Election Commissioner (New Delhi) where he has given clarification for the period of 2019-20 and 2020-2021 i.e. (2019-21) was declared a Zero term and accordingly tenure of branch executive body as well as Head Quarter Office bearers and council members was extended by two years i.e. up to 2023 and hence period of (2019-23) will be treated as one term of two years from the purpose of eligibility criteria for the post of Chairman/Hony Secretary.
9. As per para 27.5 (g) MOA any Chairman who has served a full term is not eligible for the post of Hony Secretary can only contest after a gap of one tenure.
10. Election process shall be adopted as per the MOA.
11. All contesting aspirants are requested to bring two copies of their passport size photographs in the election meeting.
12. The election shall be held for the following post of Office Bearers: -
 - i) Chairman 1 Post
 - ii) Sr Vice Chairman 1 Post
 - iii) Vice Chairman 3 post
 - iv) Hony. Secretary 1 Post
 - v) Hony. Jt. Secretary 3 Post
 - vi) Hony. Treasurer 1 Post
 - vii) Council Members 23 Post
 - viii) Executive Committee Members 50 Post
13. Members intending to participate on any of the above posts can get the nomination form from office of the Delhi branch 106 Kirti deep, Building, Nangal Raya from 15th June 2023 to 19th June 2023.
14. In compliance to above cited it is informed to all members of MESBAI Delhi Branch that the election of Office Bearers, Council Members and Executive Committee Members of Delhi Branch will be held as per following schedule,

- i) Date of Election : 28.06.2023
- ii) Election Venue : Branch Office, 106 Kirti deep, Building, Nangal Raya (Voting time) 9AM to 4 PM
- iii) Last date of submission of form : 20.06.2023 up to 5 PM (to be submitted at office of the branch)
- iv) Last date of scrutiny of forms : 22.06.2023 up to 5 PM
- v) Last date of withdrawal of forms : 23.06.2023
- vi) Date of Bi-ennial general meeting : 24.06.2023 at 3 PM at Dee Marks Hotel & Resorts, Near Indira Gandhi International Airport, NH-8, Delhi Jaipur Highway adjoining Shiv Murti, New Delhi -110037

15. After voting process is over the results shall be announced thereafter on the same day followed by installation Ceremony of new Elected Team and fellowship.
