**MINUTES OF THE DRRC MEETING HELD ON 3<sup>rd</sup> Nov 2024 ON GOOGLE MEET VIDEO  
CONFERENCING**

2 The following disputes in the form of Representations received were discussed in the DRRC meeting:-

- (i) Representation received from Sh Naveen Yadav Immediate Past Chairman Lucknow Branch regarding restoration of membership of Sh Atul Prashar made by him under his Letter dated 04 Sept 2024.
- (ii) Representation made by Sh Jitesh Bambani of M/S Poonam Electric Industry, Bhopal member of Bhopal Branch against his expulsion from MES Builders Association of India ( REGD) under his Letters dated 2nd Oct 2024, 13<sup>th</sup> Oct 2024 and 27<sup>th</sup> Oct 2024.
- (iii) Representation made by Sh Harender B Tulsania of Pune Branch under his letter dt 18<sup>th</sup> Oct 2024 received on 25<sup>th</sup> Oct 2024.

3 The DRRC discussed all the representations made by the Individuals under their respective letters as received. Detailed discussions were held on each matter with the documents held on records & in accordance with the Memorandum & Articles of M E S Builders Association of

India (REGD) {in short further referred as MOA} and DRRC unanimously taken decision on each issue as detailed below:-

- (i) On the Representation made by Sh Naveen Yadav( Ref 2(i) above) :-

It was Unanimously decided by the DRRC that the restoration of membership of S Atul Parashar was in order as per MOA provisions, legally valid & as per laid down procedure. Further to that as per Article No 23 (e ) of MOA, the decision given by the DRRC is Final & Binding.

- (ii) On the representation made by Sh Jitesh Bhambani ( Refer 2 (ii) above):-

After Going through all the representation made by Sh Jitesh Bhambani and records held and made available to the DRRC, the representation made by the Sh Jitesh Bhambani member of Bhopal Branch was examined in detailed. This was found that Sh Jitesh Bhambani was earlier also terminated from Association by the Bhopal branch on account of failure to clear outstanding dues of his firm with the Branch.

It was found from the records that he Publically & on social media posted unwarranted allegations against the office bearers of HQ , adding one particular mobile number on WhatsApp group and denied to disclose the Identity of that person and subsequently alleging parent organization MES BAI and particularly office bearers of HQ and senior members of Association which were found very injurious for the Association. The decision for expulsion of Sh Jitesh Bhambani from Association was taken by the President in the interest of Association under the provisions of MOA. From the events / posts of Sh Jitesh Bhambani after losing elections in Bhopal branch and so many times even after his expulsion, threatened in his various letters addressed to DRRC which were also send through email to other persons other than the members of DRRC which is a serious misconduct on his part and destroy the sanctity of DRRC.

After examining the records based on which Sh Jitesh Bhambani was expelled and observation as above , the DRRC comes to the decision that for maintaining dignity & respect of Association, the decision taken by President of expulsion of Sh Jitesh Bhambani holds good. The DRRC Further advised to the HQ to issue show cause notice to Sh Jitesh Bhambani as per MOA provisions and further action for decision of termination of his membership from the Association or any other suitable action in the best interest of Association may be taken in the Council meeting thereafter.

- (iii) On the Representation made by Sh Hierender B Tulsanis ( refer 2 (iii) above ) :-

Though the DRRC has received a single page representation from Sh Hierender B Tulsania, Though the matter is related to Election Term of 23-25, the applicant should have represented at that time as per MOA provisions but to maintain better transparency it was unanimously decided that the matter may be discussed first in the council meeting and council may take



appropriate action including formation of a committee to collect & verify the facts on the letter of Sh Hiernder B Tulsania and take further action to resolves the issue raised by Sh Hiernder B Tulsania of Pune Branch.

4. It was also unanimously decided by the members that the DRRC will take cognizance on matters only on the matters which are directly addressed to DRRC and not on any matter / letter with a copy endorsed to DRRC in future.
