**Sh. Sarabjeet Singh** Sir we have objection for Bareilly branch as we had sent 7 applications.

**Sh. G.S. Mago** President stated that we will recheck the details with the headquarter and share the verified information with you. We will clarify the matter based on office records and provide the actual number of members. The issue of Bareilly will also be resolved shortly. He further conveyed that Sh Sarabjeet Singh Ji, if you do not approve the membership applications within the stipulated time, the headquarter will process them if they are found in order. Membership applications cannot be kept pending for months. As per the rules, applications must be submitted to the headquarters within 45 days of receipt. After this period, the headquarters has the authority to take a decision. However, if an applicant has not paid the subscription fee, is

not enlisted or is found to be fraudulent, the membership will not be approved. If there is no response from your end, we have the authority to approve the membership applications accordingly.

**Sh. Sarabjeet Singh** We received the application on 8<sup>th</sup> February 2025. However, you are approving it within 10 days without obtaining branch approval, despite the fact that the branch has not yet received the subscription fees. Moreover, the membership application form includes an individual who is neither the proprietor nor a partner of the firm. We have also sent you letters regarding this matter twice previously.

**Sh. G.S. Mago** Stated that as per records, we will verify the matter and if it is found incorrect, it will not be circulated. However, if it is found correct we will proceed with its circulation. It is concerning that the political influence of a specific branch is strong enough to hinder fair decision making. We should focus on encouraging individuals to become our members. In fact, we have successfully added more than 1000 new members in this year. I also earnestly request everyone to refrain from cross taking as per the guidelines outlined in our MOA. Any misconduct will not be tolerated and I will have no hesitation in asking individuals to leave if they disrupt proceedings. I am fully aware of the authority vested in the dais. With so many representatives present from across India, I assure you that the Bareilly matter will be thoroughly investigated. If found incorrect, it will not be circulated, however, if it aligns with the MOA we will proceed accordingly.

**Sh. Naveen Kumar Yadav** I extend my heartfelt congratulations to you Sir, on the remarkable achievement of adding over 1000 new members to the Association during this tenure. I sincerely hope that we will see even more members join before our upcoming Bhopal meeting. As you mentioned, if an application is received and the respective branch does not approve it, the headquarters holds the authority to accept and approve the applicant as a member. As a Council member, I seek clarification regarding the Nasirabad branch have the applications from this branch been approved or not? I would appreciate further elaboration on this matter.

**Sh. G.S. Mago** The branch in Nasirabad has not yet opened. We have distributed the members' present stance. We shall review, approve, and proclaim them at the next meeting in accordance with the MOA.

After detailed discussions memberships were confirmed and approved by the Council unanimously.

**Sh. G.S. Mago** I request Sh. Vinod Bahl to appraise the House.

**Sh. Vinod Bahl** I am grateful, President Sir. All the relevant documents, the Branch's suggestions, their General Body decisions and correspondence have been received and forwarded to Headquarters by the Branch. The Branch Chairman is also in attendance. He will talk about this if you let him, but I believe there have been a number of instances that have seriously strained the Association's unity. For instance, if a Past Chairman or any past office bearer while writing letters to the department they use the same designation on their letter heads. Is that correct? There have been numerous such instances, and the branch is truly suffering. I would request the Branch Chairman to comment on this with the approval of the President and the officiating General Secretary.

**Sh. Khursheed Ahmad Lone** Sir its more than 2 year that they did not handover the account. Also, he freeze the account.

After detailed discussions Termination of 2 memberships were confirmed and approved by the Council unanimously.

**Sh. G.S. Mago** I sincerely thank everyone present here for their cooperation. There was a brief interaction with the Bareilly Branch which should be taken in the spirit of sportsmanship. As the saying goes, when two utensils are in the same house, they may occasionally clash. However, in the end, our goal remains justice and mutual understanding. Our efforts are not limited to a select few but are dedicated to the well being of each and every individual. With this, I extend my gratitude to all once again.

**Sh. Prasanta Mahanta** Discussion on Revival of Pitthoragarh Branch.

**Sh. Atul Arora** The Pithoragarh branch was established under the leadership of past President Sh Varinder Garg when he secured a Rs 270 crore tender. However, it is regrettable that, from the very beginning, this branch has not participated in any association activities nor has it cleared any dues. Furthermore, it has not contributed even a single initiative during the session. Given that the branch is effectively inactive, I question the need to repeatedly bring it up as an agenda point. If it is already non functional, it may be time to move forward and focus on more relevant matter.

**Sh. G.S. Mago** You told me that Sh. Anil Kapoor from the dais stated that since we are restarting the Pitthoragarh branch, we cannot take these people into consideration. You would have to show confirmation of the Council Meeting.

**Sh. Atul Arora** In 2018, an application for 10 members from Pithoragarh was submitted alongwith the required payment. The Secretary informed that the GST amount also needs to be deposited at both the HQ and the branch. Furthermore, the application form clearly includes an optiown for selecting the branch under which membership is required and they explicitly mentioned |Bareilly Branch. Approximately 20 members of the Bareilly Branch are curre3ntly working in Ranikhet and seek services from the Bareilly Branch. I do not believe HQ would disregard their request by reviving an inactive branch. The Pithoragarh branch has remained non functional for the past seven years, and we have documentary proof of this. It is my humble request that the application which has already been reviewed and approved by the Bareilly branch, be formally approved by HQ, as the subscription fee and GST amount have already been deposited. It is inappro0priate for a senior member to claim ownership of the Bareilly Branch and refuse approvals arbitrarily. We also have a copy of the Vice President's email, letters ffrom the Secretary and President and other supporting documents. This matter dates back to 31 Jan 2017 and I will submit the complete file of evidence for reference.

**Sh. Sarabjeet Singh** All application forms were already forwarded through HQ and since they were rejected in the General Body Meeting, this matter is no longer an issue. The only viable option now is to establish a new branch, as the Bareilly Branch is unable to provide services to them. It is important to note that the rejection was made by HQ in 2018 but not by us. Since then, we have not received any further applications. Moreover, the concerned individuals have been unable to provide proof of their subscription payment. Furthermore, given the distance of 270 Km, it is impractical for us to extend services to them effectively.

**Sh. G.S. Mago** Now I request Sh. Vinod Bahl to kindly appraise the House.

**Sh. Vinod Bahl** Stated that the matter has been complicated for a long time. I have been dealing with it for the past 47 years as well. When we receive application forms and there is no branch available in a particular location, we often grant membership directly under HQ. In some cases, we assign them to the nearest branch. Seeking approval from a branch in such cases is not the right approach. The primary concern should be ensuring membership in the association. Whether they become direct members or are assigned to a branch can be decided later as a subsequent matter. Therefore, I request that the membership be granted first and then we can determine the appropriate branch assignment if needed.

**Sh. V.P. Sanjeev** There is a column on the application form that asks which branch you wish to join. We cannot expect a member to give them another branch if they write a certain branch name. Since the Ranchi branch currently controls two states, we have complete authority over everything we desire.

**Sh. Vinay Saini** Sir Sh. Sunil Panwar also visited the location and made efforts to revive the members. I, too visited the place and the local members expressed their interest in establishing a new branch there.

**Sh. G.S. Mago** Now, I am going to give my verdict regarding the applicants who applied for membership under the Bareilly Branch from Pithoragarh. The Headquarters made significant efforts and personally held a meeting with the Bareilly Branch on 02<sup>nd</sup> February 2025, in which the Chairman, Secretary, Shri Sanjay Varshney and other members were present. In the meeting, it was decided that membership approval would be granted to 5,7 or 9 applicants. For the remaining applicants, we will focus on opening and reviving the Pithoragarh Branch. This issue was discussed with Shri Sunil Panwar, Shri Sandeep Srivastava. Sh. Sunil Panwar, suggested that a portion of the amount should be waived off. Today the Kargil branch informed us about the specific amount they are contributing and it was decided that the remaining amount should be waived off. This proposal was reviewed and subsequently approved. Regarding the Pithoragarh Branch, dedicated efforts are being made for its revival. A timeframe of 10 to 15 days has been granted to the Bareilly Branch for revival with the waiver to be provided as per the discretion of the Vice President. If the Vice President is unable to facilitate this within the given period, the headquarters will proceed with approving the pending members under the Bareilly Branch.

After detailed discussion, this decision was confirmed and approved by the Council unanimously.

**Sh. G.S. Mago** I would like to bring to the house's attention that for the past one or two months, I have been receiving threatening messages from a Pune base member, Mr Harendra Tulsani. He has been sending me messages daily, creating an atmosphere of intimidation. Today, I received another such message which reads as follows:-

“Good morning, Mr. Mago. I heard a poem today, I have seen a thief and another thief is his cousin brother. The way you spoke had the opposite effect but it does not matter. I am lodging a complaint against you and will continue to do so” However, two to three days ago, I received a letter stating that he intends to file a complaint with the Registrar of Societies, alleging bias and injustice on my part. I also have some inputs regarding the Pune branch and the individual concerned, which I would like to brief the house about. It is important to assess the credibility and status of the complainant to ensure transparency and fairness in addressing these matters”.

**Sh. Manish Raj Malik** The individual in question is Mr Harendra B Tulsani of M/s TH Associates. He served as a council member for the 2021-2023 term but has failed to clear his Association dues including souvenir charges for the annual days for both years. Moreover, he

has not made any contributions over the past here years. As of now his total outstanding dues amount is Rs 52,037.00. In accordance with the Memorandum of Association (MOA), if arrears remain unpaid for more than six months, all services to the concerned member must be discontinued. Consequently we have stopped all services to him. Despite this, Mr Tulsani is now resorting to threats against the Headquarters and the President. Given this actions, why should we not proceed with disciplinary action against him? It is imperative that we uphold the rules and take appropriate measures in such cases.

**Sh. G.S. Mago** Please share your opinions from the House so that we can take action.

**Sh. M.A. Wani** Sir, you have received a message stating that a thief and another thief are cousin brothers. Such messages are completely unacceptable and we must collectively condemn them. As responsible members, we should take a firm and united stand against such behaviour. According to the Memorandum of Association (MOA) of our Association, , maintaining decency and decorum is our fundamental duty. Decency is a value we inherit from our rich heritage and without it, meaningful discussions lose their essence. In my personal opinion, any member engaging in such misconduct should face strict action including permanent termination from the Association. Respect is the foundation of our organisation and any violation of it cannot be tolerated. As an example, if I were to face an issue in Delhi, I believe that my fellow members here are like my family, ready to support and guide me. Such trust and mutual respect must be preserved at all costs.

**Sh. Gurjeet Singh Ahluwalia** I will request the Chairman and Secretary of Pune branch to recognise that this threat is not just directed at the President, but concerns all of us. We must take this matter seriously and file an FIR against him to ensure the safety and integrity of our organisation.

**Sh. Manish Raj Malik** Stated that we will follow the instruction as per HQ suggesstion.

**Sh. G.S. Mago** So this House permits termination of Harendra Tulsani right now.

**Sh. Rajeev Chowdhary** Please expel him for whole life.

**Sh. Mandeep Grewal** I think we should first issue a formal notice to him. This will ensure that if he raises any objections regarding the lack of prior communication about his termination, we have a documented record of due process. Once the notice has been served, we can proceed with appropriate disciplinary action if necessary.

**Sh. G.S. Mago** This is not the first time. He also called to Sh. Lakhbir Singh and Sh V.P. Sanjeev also.

**Sh. Vivek Manghnani** Sir please ensure that no loose points remain, so we do not encounter issues similar to those faced earlier. It is important to address all aspects thoroughly to avoid any complications in the future.

**Sh. Badri Mander** I agree with Sh Vivek, however, in this case, he is not communicating with the branch at all. Instead, he is directly sending messages and letters to you. As per the branch's records, he is not considered a member since he has been defaulting for the past three years. Moreover, we do not have any formal letter or message that would warrant a recommendation from the branch to HQ for action against him. Given these circumstances, I believe the AGM is the appropriate and sufficient authority to decide on this matter. Whatever decision the AGM takes will be binding on us.

**Sh. G.S. Mago** As per the AGM's decision, the President is satisfied that he is unfit to remain a part of the Association and should be terminated with immediate effect for a lifetime. It has been duly amended to expel him and no prior notice is required as the action is legally valid. Meanwhile, if necessary, we will take parallel action. It is also officially recorded that he stands expelled from today for a lifetime.


After detailed discussions termination of Sh. Harendra B Tulsani was confirmed and approved by the Council unanimously.
