Action to be taken by the branch

1. Branch Secretary will convene the Executive Committee meeting of the branch immediately with consultation with the branch Chairman by giving a clear seven days' notice and circulate it to all executive committee members. **Such notice of EC Meeting of the branch must published on or before 28 may (Wednesday Day) 2025**
2. The Notice of such Executive Committee meeting must reach to the Election Commission in E-Mail ID: ecmbai2527@gmail.com within 24 hours of publishing and the hard copy of the same may be sent to the HQ of MES BAI by speed post/courier.
3. The first agenda of the Executive meeting is to select/elect the Election Chairman to conduct the election of the branch amongst the members of the branch.
4. A date and venue will have to be fix for the AGM cum Election meeting of the branch in the executive committee meeting and a clear 21 days' notice has to be circulated amongst the general members. The election notice will be circulated under the signature of election chairman with his E-mail ID and WhatsApp Number. **Such notice of EC Meeting of the branch must published on or before 09 June (Mon Day) 2025**
5. The Notice of such Election meeting and AGM meeting must reach to the Election Commission in E-Mail ID: ecmbai2527@gmail.com within 24 hours of publishing and the hard copy of the same may be sent to the HQ of MES BAI by speed post/courier.
6. The valid Voter list for the branch election is available in the MESBAI website and branch election will be held only with the member list of the branch available in MESBAI website.
