Subject : Formal Objection to Unconstitutional Actions – Dissolution of Chief Election Commissioner, Convening of Special Council Meeting & Misinterpretation of Clause 12.1 of MOA

Respected Sir,

I write to you in my official capacity as the **Hon. General Secretary of MES BAI** for the tenure 2023–2025, by the Memorandum of Association (MOA), Societies Registration Act, 1860, and the spirit of the Constitution of MES BAI.

It is with deep concern and constitutional responsibility that I bring to your urgent attention the following grave issues surrounding the illegal Special Council Meeting and associated actions:

1. Unlawful Interference by DRRC with Presidential Support:

The DRRC, an internal advisory body for dispute resolution, **has no constitutional authority in the association's electoral process during the election process**, which spans from April to July of the election year. **Please refer to clause 11 g (xi)** in this regard for disputes in election-related matters and the power delegated to DRRC. However, with your express support, its recommendations were wrongly used to justify an attempted and unlawful dissolution of the Election Commission. This collusion is a direct attempt to **sabotage the democratic election process** and is a serious breach of MES BAI's constitutional fabric.

2. Adherence to Clause 11(f)(xii, xiii, xiv) – Non-Intervention in Election Matters

Concerning the ongoing election disputes concerning the Delhi Branch, it is important to draw attention to **Clause 11(f)(xii, xiii, xiv) of the relevant governing rules of MOA**. As per these provisions, the decisions of the Election Commission (EC) are final and binding on all parties involved throughout the election process, which spans from April to July of the election year.

Accordingly, no individual, including the President or any internal body of the organisation, holds the authority to intervene or interfere in matters that fall under the exclusive jurisdiction of the Election Commission during this period.

All stakeholders are, therefore, expected to comply strictly with the decisions of the EC to ensure the integrity and fairness of the election process.

1. Unconstitutional Dissolution of the Chief Election Commissioner (CEC):

The CEC was elected democratically on **9th April 2025** in Bhopal, through due process, by a significant democratic margin of **37 votes**. The CEC thereafter took charge and began functioning lawfully under the powers provided in **Clause 11** of the MOA.

Your unilateral attempt to dissolve the Chief Election Commissioner, mid-election, without any Executive Body resolution or due cause, is a clear violation of the provisions and infringes upon the autonomy of the electoral authority of MES BAI.

2. Illegality of Special Council Meeting under Clause 12.1 of MOA:

You have relied on **Clause 12.1** of the MOA to justify the convening of a Special Council Meeting; however, this clause must be read with other procedural requirements.

The Special Council Meeting was not authorized by the Executive Committee or General Council, nor was it convened in consultation with the Hon. General Secretary or through any valid requisition supported by the required number of members. Hence, this meeting is illegal, illegitimate, and void ab initio.

More than **43 branches** have formally expressed their **refusal to attend** the said unconstitutional meeting (list attached). Several others are under pressure not to express dissent, yet they remain in support of constitutional procedure.

5. Intervention in Electoral Process:

Elections are the exclusive domain of the **Chief Election Commissioner**, duly constituted as per the MOA. Your attempts to interfere with and override the decisions of the CEC, such as venue selection, election dates, and candidate validation, constitute a direct attack on the sanctity of MES BAI's democratic processes.

Already, **79 branches** have declared, and many have concluded their elections based on the notifications issued by the CEC. Intervening at this stage undermines the institution's credibility and invites legal implications.

6. Violation of the Societies Registration Act, 1860:

Under the **Societies Registration Act, 1860**, any registered society must function through its governing documents. Arbitrary dissolution of duly constituted authorities and calling meetings without due process violate the foundational principles of the Act. Such actions may be challenged before the Registrar of Societies and the appropriate courts.

6. Legal Advice and Caution:

You are hereby advised, with utmost respect, to immediately refrain from:

- Proceeding with the Special Council Meeting was declared without proper authorization
- Misrepresenting Clause 12.1 to circumvent constitutional checks
- Interfering in the legitimate functions of the Chief Election Commissioner

Failure to do so may compel us to seek judicial redress and approach statutory bodies, including the **Registrar of Societies** and the **High Court**, under Writ Jurisdiction, to protect the constitutional order of MES BAI.
