Dear Sir,

- (1) Please refer to Election Commission Circular No 25-27/01 dated 02 June 2025.
- (2) It is intimated to all the concerned to conduct Branch Elections to adhere to all the time lines fixed by the previous Election commission for conducting of Branch election (without failure) in cordially free & fair Elections.
- (3) It is therefore, once again advised to all Chairmen/ Hony Secretaries of all concerned branches who have not yet fixed the Date of Executive Body Meeting of Branch or even not issued Notice/ Intimation to Executive Committee members regarding convening of Branch Executive Body Meeting to Elect Election Chairman for Branch Elections and to decide date/ venue & method of Branch Elections as per the Memorandum of Association.
- (4) All those Branches who falls under Para (3) above, are advised to Convene Executive Body Meeting of Branch immediately and Elect Election Chairman for conducting Branch Elections as per the advisory issued by previous Election Commission & provisions of MOA and intimate the same to Election Commission without fail if not done yet.
- (5) Please ensure that the Notice of election of Branches should be issued prior to 9th June 2025 so that minimum notice period of 21 days as per MOA provisions be adhered to.
- (6) As per the resolution passed in the Special Council Meeting held on 02 June 2025 at New Delhi it is being intimate that elections of those branches where elections are already held strictly as per the provisions of MOA of Association, they will stands hold good.
- (7) As per the resolution passed in the Special Council Meeting it is being intimate that elections of those branches where elections are already held without following the provisions of MOA and AOA of Association and directions issued by DRRC, the elections of those Branches will be subjected to scrutiny by the Election Commission which will be intimated separately. However Re-Elections of these branches will be exempted from mandatory 21 days notice.

(8) For those Branches where elections are not held but election process has been started should continue their election process by adhering strictly the Memorandum and Articles of Association. These branches are requested to forward their election program to this Election Commission forthwith.
