
1. Further reference to Election Circular No 1 date 02nd June 2025 under it was conveyed for information of all concerned that a new Election Commission of our esteemed organization has been constituted in the Special Council Meeting held on 02 June 2025 at Hotel Signature Grand, New Delhi, undersigned as the Chief Election Commissioner with Sri Sh. R.M. Singhvi and Sri Prem Nath Roy are Election Commissioner, to conduct the election of our Association.
2. Due to certain legal issues, the working of Election Commission for continuing the ensuing Election Process for 2025-2027 for which it was constituted by the Council on 02nd of June 2025 had been kept in abeyance.
3. Now as per the Information received from the President of Association conveyed to Election Commission under their letter dated 05 Aug 2025 that the injunction on further proceedings of continuing the Election Process is now No more in existence since the directives issued on 04th June 2025 by Honorable Delhi High Court were applicable up to Next Date of Hearing After the Mediation Proceedings ordered by the Honorable Delhi High Court i.e 21st July 2025 and case was already heard on 21st July 2025/ 31st July 2025 and now Next date of hearing of matter is fixed to 19th November 2025, the Election Commission after Holding virtual Meeting on 05th Aug 2025, had decided to proceed with to conduct Elections for remaining Branches which remained without Election process completed as on 04th Jun 2025 & for those Branches where The election commission found irregularities in Branch Elections conducted in violation of

Articles of MOA and decided for Re-Elections. The Elections for HQ Office Bearers will also be conducted in Due course in accordance with the Guidelines given under Articles of Association.

4. The Detailed Election Schedule for Branch Elections and HQ Office Bearers Elections will be published Separately.
5.
