**Subject: Adjudication on Complaint made by Sh Narender Kumar , Election Chairman, MES BAI DELHI BRANCH on Issue of Lack of authority to issue Delhi Branch Election Circular Aug/03 dated 09.08.2025, post-dissolution of Election Commission vide special council resolution dated 02.06.2025.**

Dear Sir(s)

1. A complaint received by the DRRC from Sh Narender Kumar, Election Chairman, MES BAI DELHI BRANCH under his letter No MBAI/Election/DB/12/20 25-27 Dated 10Aug 2025 to adjudicate the matter of **Issue of Lack of authority to issue Delhi Branch Election Circular Aug/03 dated 09.08.2025, post-dissolution of Election Commission vide special council resolution dated 02.06.2025.**
2. As circulated and well intimated to all the concerned in the matter about the DRRC meeting on 11<sup>th</sup> August 2025 through Virtual meeting by the DRRC & HQ MES BAI New Delhi well within time. The Complainant Sh Narender Kumar was Present in the meeting.
3. The DRRC had examined and decided that the matter forwarded under the complaint of Sh Narender Kumar is appropriate to be adjudicated under Article 23(a),(d),(e) & and (f)Articles of Association and falls under the authority of DRRC to be heard and pronounce its Decision.
4. The DRRC observed the following submission submitted by the complainant Sh Narender Kumar :-
  - (a) that Sh Praveen Mahana, Sh Amit Bhaduri & Sh Naveen Kumar Yadav, all the three who were the members of Dissolved Election commission had absolutely no authority whatsoever to issue any

communication, instruction, order, or circular in relation to the conduct of elections at any branch, including the Delhi Branch, of MES Builders Association of India (Regd.), subsequent to the resolution passed in the Special Council Meeting dated 02.06.2025 under which the Election Commission consisting of all you three individuals was dissolved. You are, at present, only a member of the Association and hold no authority to conduct elections or to interfere in or assume any role in ongoing branch election processes in any capacity.

(b) As Sh Praveen Mahana, Sh Amit Bhaduri & Sh Naveen Kumar Yadav, all the three who were the members of Dissolved Election commission fully aware of the fact that the Special Council Meeting of M.E.S. Builders Association of India (Regd.) was convened on 02 June 2025 at Hotel Signature Grand, New Delhi, wherein it was unanimously resolved to dissolve the Election Commission elected at the Bhopal Council Meeting consisting of Praveen Mahana, Amit Bhaduri and Naveen Kumar Yadav. This resolution was passed strictly in accordance with the powers vested to the Council under the MoA and AoA of the Association. The relevant extract from said resolution is hereby extracted below:

**“The Council unanimously further resolved to dissolve the Election Commission comprising of Sh. Praveen Mahana as Chief Election Commissioner, Sh. Naveen Kumar Yadav and Sh. Amit Bhaduri as Election Commissioner with immediate effect from today 02 Jun 2025 onwards since it is not conducting the ongoing elections as per provisions laid down under the Constitution (MOA/AOA as amended up to 31/07/2024) of Association. As such the Election Commission elected in Bhopal Council meeting held on 09 April 2025 is not functioning for conducting elections of Branches and HQ Office Bearers in free and fair manner which is a primary requirement.”**

(c) It has already been directed by various letters of the HQ letter vide Ref No. MBAI/election/SCM/2025-27-01 dated 02.06.2025, Ref No. Letter No. MBAI/Election/SCM/2025-27/02 dated 02.06.2025, Ref Letter No. MBAI/PP/17/25 dated 05 Aug 2025 that All branches, office bearers and members of MES BAI are directed to adhere to the Resolution passed in special council meeting dated 02.06.2025, and act only upon communications issued by the duly constituted Election Commission (2025-2027), comprising of Shri Narendra Kumar Gupta (CEC), Shri R.M. Singhvi (EC) and Shri Prem Nath Roy (EC) after 02/06/2025.

(d) It was further stated by Sh Narendra Kumar that the Dissolved Election Commissioner Sh. Praveen Mahana & team tried to interfere in Delhi Branch from the day one when Delhi Branch announced executive body meeting to be held at Hotel Signature Grand Hari Nagar New Delhi - 110064 on 28/04/2025, but on 27/04/2025 vide election circular No. 16 Sh. Praveen Mahana & team given direction to the branch to only elect election Chairman of Delhi Branch and rest arrangement to conduct the election of Delhi Branch will be finalized with collective consultation with election commission, branch election chairman, branch chairman and branch Hony. Secretary. This was a clear cut violation of Article No 11 (f) vi of MOA. The venue and date of election have to be decided by executive body of Branch. Once again the Dissolved election commissioner has issued the Circular No. 20 dated 30/04/2025 and given direction that executive body meeting minutes dated 29/04/2025 of Para (3) & (4) of the minutes of executive body meeting as null and void. Please refer circular No. 23 dated 02/05/2025 of defunct election commissioner in which the membership of M/s M.P Tyagi Engineers & Contractor was restored against the MOA condition No. 11(f) (iii) in which during the April to July of election year the membership can not be enrolled. Once again refer circular No. 25 dated 05/05/2025 of Dissolved election commissioner given the direction to conduct the election notice under his signature. Please refer circular No. 47 dated 16/05/2025 of Dissolved election commissioner has been issued election notice without the consultation of branch election chairman and venue of election was booked in cash without intimation to Delhi branch and HQ of MES BAI.

(e). Sh Narendra Kumar further stated that In compliance of the aforesaid, he had already issued



detailed instructions and timeline for the holding of Delhi Branch elections vide letter dated 08.08.2025 and informed the same to the Competent election commission constituted on 02.06.2025. It appears that all three viz Sh Praveen Mahana, Sh Amit Bhaduri & Sh Naveen Kumar Yadav, all are who were the members of Dissolved Election commission are trying to act as imposters by illegally issuing circulars in the capacity of so proclaimed election commission which was already been dissolved and they have no authority to act against the resolution dated 02.06.2025 passed by the Supreme Authority of Association viz Council.

- (f) Sh Narender Kumar further stated that all three viz Shri Praveen Mahana, Shri Amit Bhaduri and Shri Naveen Kumar Yadav, ceased to hold any authority to act, communicate or issue directions in the capacity of the Election Commission. Accordingly, any instructions, orders, notices or circulars issued by them thereafter **including Election Circular No. Aug/03 dated 09 August 2025 regarding the Delhi Branch elections scheduled for 21 August 2025** stands no legal sanctity and are null and void since the same carry no legal or constitutional validity. The said circular has no standing and shall not be acted upon by the Delhi Branch or its members.
- (g) Sh Narender Kumar further stated that The only body lawfully empowered to conduct and supervise elections at this time is the Election Commission (2025-2027) constituted on 02 June 2025, comprising Shri Narendra Kumar Gupta (Chief Election Commissioner), Shri R.M. Singhvi (Election Commissioner) and Shri Prem Nath Roy (Election Commissioner). All ongoing election processes, including those of the Delhi Branch, are being conducted exclusively under the supervision of this duly appointed Election Commission (2025-2027) by Council on 02 Jun 2025.
- (h) Sh Narender Kumar further stated that Any continued attempt to act, represent or communicate in the capacity of Election Commission by all three viz Shri Praveen Mahana, Shri Amit Bhaduri and Shri Naveen Kumar Yadav, particularly in connection with the Delhi Branch elections, will be ignored and treated as a serious violation of the Association's constitution.
- (j) It is a matter of fact that the action of all three viz Shri Praveen Mahana, Shri Amit Bhaduri and Shri Naveen Kumar Yadav, to issue the circular by acting in the capacity of election commission without being authority to do so is a serious breach of MoA and AoA of the Association. Sh Narender Kumar also warned them that he is also making a complaint to the Dispute Redress and Resolution Committee (DRRC), against all all three viz Shri Praveen Mahana, Shri Amit Bhaduri and Shri Naveen Kumar Yadav to initiate disciplinary action for issuance of unauthorized circulars without being any authority to do so.
- (k) All three viz Shri Praveen Mahana, Shri Amit Bhaduri and Shri Naveen Kumar Yadav, are therefore advised by Sh Narender Kumar to refrain from issuing any further communications purporting to exercise the powers of the Election Commission. All members and branches, including the Delhi Branch, have been instructed by the President of Association to recognize and act only upon communications issued by the duly constituted Election Commission comprising Shri Narendra Kumar Gupta (Chief Election Commissioner), Shri R.M. Singhvi (Election Commissioner) and Shri Prem Nath Roy (Election Commissioner) by the President of HQ in compliance to the decisions taken in the Special Council meeting held on 02<sup>nd</sup> June 2025 at New Delhi and requested to all three viz Shri Praveen Mahana, Shri Amit Bhaduri and Shri Naveen Kumar Yadav cooperation in ceasing any parallel or unauthorized processes is necessary to uphold the democratic and constitutional integrity of the Association.
- 5) (a) After examination of All facts submitted by the complainant Sh Narender Kumar, Election Chairman Delhi Branch DRRC comes to its conclusion that the trio Shri Praveen Mahana, Shri Amit Bhaduri and Shri Naveen Kumar Yadav ( members of Dissolved Election commission) were deliberately interfering in Election process of Delhi Branch with one side biased manner to support his choice of Group from day one the Election process of Delhi Branch yet to start. Under their

tenure up to 02 nd of June ( the date on which Council dissolved the Election Commission consisting of trio Shri Praveen Mahana, Shri Amit Bhaduri and Shri Naveen Kumar Yadav), the Election commission the trio Shri Praveen Mahana, Shri Amit Bhaduri and Shri Naveen Kumar Yadav had issued circulars/ instructions mostly targeting the Delhi Branch Elections which are beyond the provisions of Memorandum and Articles of Association of M E S BUILDERS ASSOCIATION OF INDIA( REGD) and on fabricated false grounds.

(b) It had been also observed by the DRRC that trio of Shri Praveen Mahana, Shri Amit Bhaduri and Shri Naveen Kumar Yadav are intentionally indulged in to derail the Election process of Delhi Branch by unwarranted actions. The DRRC recommends to the President / Council to take immediate cognizance of these irregularities and conduct of trio Shri Praveen Mahana, Shri Amit Bhaduri and Shri Naveen Kumar Yadav and take disciplinary action against them to maintain the Sanctity of Association.

**6. Upon careful examination of all facts, records, and documents pertaining to the matter and after due consideration, the Dispute Redressal & Review Committee (DRRC) hereby states the following :**

- i. It is established that Shri Praveen Mahana, Shri Amit Bhaduri, and Shri Naveen Kumar Yadav, formerly members of the Dissolved Election Commission, have acted beyond their authority and in contravention of the Memorandum and Articles of Association of MES Builders Association of India (Regd.), and their actions constitute anti-Association activities.
- ii. It is further found that the issuance of Election Circular No. Aug/03 dated 09 August 2025, and any subsequent circulars issued under the signatures of the aforementioned trio, are wholly illegal and without sanction of law.
- iii. It is also established that the appointment of Sh Amritpal Singh as Branch Election Chairman and the issuance of Election Circular No. Election01 dated 10/08/2025 by him is unauthorized and has no legal standing.
- iv. It is established that only lawfully empowered to conduct and supervise elections at this time is the Election Commission (2025-2027) constituted on 02 June 2025, comprising Shri Narendra Kumar Gupta (Chief Election Commissioner), Shri R.M. Singhvi (Election Commissioner) and Shri Prem Nath Roy (Election Commissioner).

**7. DRRC decisionn and directions**

- I. Circular No. Aug/03 dated 09 August 2025 issued by Shri Praveen Mahana, Shri Amit Bhaduri, and Shri Naveen Kumar Yadav, purportedly acting as members of the Election Commission, is declared null and void. This circular, and all subsequent communications or directives issued by this group concerning the Delhi Branch elections, are hereby quashed.
- II. Circular No. Election01 dated 10/08/2025, issued by Sh Amritpal Singh, is similarly declared null and void and stands quashed.
- III. The Delhi Branch and all its members, office bearers, and functionaries are directed not to take cognizance of either of the above-named circulars, nor of any future communications issued by the aforementioned individuals acting as or under the authority of the dissolved Election Commission.
- IV. All members of the branch are hereby directed to follow instructions only from duly elected election commission formed on 02.06.2025 comprising Shri Narendra Kumar Gupta (Chief Election Commissioner), Shri R.M. Singhvi (Election Commissioner) and Shri Prem Nath Roy

- (Election Commissioner).
- V. It is further ordered that the conduct of the Delhi branch elections shall henceforth be exclusively and lawfully carried out under the supervision of Sh Narender Kumar, who has been duly elected as the Election Chairman by the Delhi Branch Executive Committee in its meeting.
  - VI. The Secretary of the Delhi Branch is directed to communicate this order forthwith to all concerned, to record the same in the official records, and to ensure due compliance.
  - VII. Non-compliance with this Order shall be deemed a violation of the Memorandum and articles of Association and may invite appropriate disciplinary proceedings.
8. With this the Complaint made by Sh Narender Kumar, Election Chairman Delhi Branch MES BAI stands disposed.
  9. Since this meeting was held on VC all the members of DRRC authorized Sh Lakhbir Singh chairman DRRC 23-25 to sign on their behalf.
