**Reference: Your office letter no MBAI/HGS/11/2025 dated: 09 Aug 2025**

Thanks for finally realizing the prevailing situation and take step to end the impasse towards free and fair election of our esteemed organization.

1. We humbly draw your kind attention to para 1. (d) of your office letter No. MBAI/HGS/11/2025 Dated 09 Aug 2025 line 04 & 05 in which you have mentioned and we reproduce **“The DRRC shall discharge their duties in the Election process in terms of para 11 (g) (xi) MOA 2024”**
2. Now what is written to para 11 (g) (xi)? We reproduce here for all of your instant ready reference please: **“Any dissatisfied member or group of members or the Branch could approach the DRRC regarding any election related matter only after completing the HQ election. Their points of objection/grievances will have to be submitted to the DRRC in writing and duly signed by the complainant, after the HQ election is over but within 15 days of the date of HQ election. There after any objection etc. what so ever regarding election matter will not be entertained. The decision of DRRC will be final and binding for both the parties and which should come within 60 days.**
3. In your ibid letter para 1. Line 05 you have mentioned that **“CEC team elected on 09 Apr 2025 at Bhopal”** which inter alia it is substantiated that the Election process for the period of 2025-27 of MES Builders Association of India (Regd.) has started on that day itself and therefore the convening of DRRC meeting after 09 Apr 2025 till date are seriously violated the basic principle of MOA 2024 which had written in para 11 (g) (xi) as you mentioned in your ibid letter. Therefore, all the action taken by you based on so called “AWARD” (subsequently described it as not an award in Hon’ble Delhi High court) passed by DRRC on 16<sup>th</sup> Day of May 2025, including convening a special council meeting on 02 June 2025 and whatever resolution taken at that meeting including selecting a parallel Election commission is also void and has no legal bearing as per MOA 2024 what so ever.




