DECISION OF DRRC : in the matter of Adjudication in the matter of Request made by Er Rajeev Chowdhary , To Quash Illegal Election Notices Issued by the Dissolved Election Commission Comprising of Sh Praveen Mahana, Sh Amit Bhaduri & Sh Naveen Kumar Yadav

Dear Sir,

1. A complaint had been received by the DRRC from Er Rajeev Chowdhary, Council Member Jodhpur Branch C/O M/S KHETA RAM RAGHUNATH RAM CONSTRUCTION COMPANY PVT LTD Jodhpur MES BAI INDEX No – 235 under his letter No KR/R/2025 /DRRC/ Comp/CEC (D)/ 05 Dated 06 Aug 2025 for Adjudication of the matter on Priority by the DRRC.
2. As circulated and well intimated to all the concerned in the matter about the DRRC meeting will be held on 11th August 2025 through Virtual meeting by the DRRC & HQ MES BAI New Delhi well within time. The Complainant Sh Rajeev Chowdhary was Present and members of Dissolved Election Commission Sh Praveen Mahana, Sh Amit Bhaduri & Sh Naveen Kumar Yadav were remain absent.
3. The DRRC had examined and decided that the matter forwarded under the complaint of Sh Rajeev Chowdhary is appropriate to be adjudicated under Article 23(a), (e) & and (f) of Articles of Association and falls under the authority of DRRC to be heard and pronounce its Decision.
4. The DRRC observed the following from the complaint made by Sh Rajeev Chowdhary :-



- (a) This has been noticed that Shri Praveen Mahana, Shri Amit Bhaduri and Shri Naveen Yadav, have jointly issued election circulars No. Aug/01 dated 03 August 2025 to all branch election chairman intimating them to conduct the election process for remaining branches in spite of having no authority to act as an Election Commission .
- (b) This has been noticed that Shri Praveen Mahana, Shri Amit Bhaduri and Shri Naveen Yadav had taken The illegal action for their refusal to accept and implement the binding resolution of the Special Council Meeting dated 02.06.2025, and adamant for conducting Elections by issuing an unauthorized and illegal election circular purporting to act contrary as Election Commission of the Association, despite clear resolutions passed by the Council to dissolve the same.
- (c) It is surprising to notice that when in the Special Council Meeting held on 02.06.2025, a resolution was duly passed to dissolve the erstwhile Election Commission consisting of Shri Praveen Mahana, Shri Amit Bhaduri and Shri Naveen Yadav and the Council had constituted a new Election Commission in accordance with the Memorandum and Articles of Association of M E S Builders' association of India (Regd) why Sh Praveen Mahana, Sh Amit Kumar Bhaduri & Naveen Kumar Yadav are so adement to work as Election commission? The resolution to dissolve the Election Commission comprising of Sh Praveen Mahana, Sh Amit Kumar Bhaduri & Naveen Kumar Yadav having been adopted in a legally convened meeting by adopting all provisions contained in MoA & AoA of association in due process, which is binding on all members and Office Bearers of the Association.
- (d) It had been noticed that two illegal election circulars have been issued by the aforesaid three members claiming themselves to be the Election commission and disregarding the resolution passed in the Special council meeting held on 02.06.2025 (Minutes of which were Circulated under Circular No 21 dated 06.06.2025 of HQ MES BAI). Wherein a resolution was unanimously passed by the Council dissolving the erstwhile Election Commission and had constituted a new Election Commission (2025-2027) consisting Shri Narendra Kumar Gupta (Chief Election Commissioner) , Shri R.M. Singhvi (Election Commissioner) and Shri Prem Nath Roy (Election Commissioner) in accordance with the constitution and rules of the Association which are never challenged at any platform i.e. neither to DRRC nor to the court of Law by any one.
- (e) It is seriously noticed that the illegal action of the Dissolved Election Commission comprising of Shri Praveen Mahana, Shri Amit Bhaduri and Shri Naveen Yadav creates a serious threat which has led to confusion among the members and branches regarding that who is the competent authority for election-related matters and has the potential to create administrative and functional difficulties across the Association.
- (f) It is a matter of Great concern that Shri Praveen Mahana, Shri Amit Bhaduri and Shri Naveen Yadav have refused to recognize the newly constituted Election Commission formed, which was duly formed by the Council in Special Council meeting Held on 02/06/2025 and in the same



Council meeting after dissolving the erstwhile Election Commission pursuant to the resolution dated 02.06.2025. However, they continue to act as if no such resolution exists and have issued a circular in the name of the Election Commission, thereby overriding the authority of both the Council and the newly constituted Election Commission.

- (g) It is a matter of Great concern that The illegal circulars issued by Shri Praveen Mahana, Shri Amit Bhaduri and Shri Naveen Yadav, acting as the Election Commission, are unauthorized and ultra vires of the Association's constitution. It has no legal authority and has caused administrative disarray.
5. **DECISION OF DRRC :** After Perusal of all documents received with the complaint of Sh Rajeev Chowdhary which are held on records and With the observations recorded as stated in Para 4(a) to Para 4(g) above by exercising the powers vested upon to the DRRC under article No 23(a), 23 (e) & 23(f) of Memorandum and Articles of Association of M E S Builders' association of India (Regd), the complaint made by the Er Rajeev Chowdhary, Council Member ,Jodhpur Branch under his requisition made under his letter No KR/R/2025 /DRRC/ Comp/CEC (D)/ 05 Dated 06 Aug 2025 to the DRRC for adjudication is allowed and the DRRC directed to Shri Praveen Mahana, Shri Amit Bhaduri and Shri Naveen Yadav to immediately withdraw their letter within 24 Hours . In case of Shri Praveen Mahana, Shri Amit Bhaduri and Shri Naveen Yadav did not withdraw their letter the Circular No. **Aug/01 dated 03 August 2025 & other circulars issued thereafter stands quashed by the DRRC and shall be treated as Null & Void.**
6. With this the Complaint made by Er Rajeev Chowdry council member Jodhpur branch MES BAI stands disposed.
7. Since this meeting was held on VC all the members of DRRC authorized Sh Lakhbir Singh chairman DRRC 23-25 to sign on their behalf.
