- First of all, I would like to state that both I and the entire HQ Office Bearers' team are fully committed and making sincere efforts to ensure that the election of the Association is conducted at the earliest. The HQ team has been consistently trying its best. However, due to the orders of the Hon'ble Delhi High Court in cases filed by members of the dissolved Election Commission and various other members, we have not succeeded, despite our best efforts. These efforts included convening mediation meetings at the HQ level, at the personal level, as well as mediation conducted under the directions of the Hon'ble High Court. It is reiterated herein that the HQ Office Bearers' meeting, followed by the Council meeting, will be convened after 30th January 2026, and the HQ Office Bearers will again make efforts to resolve the matter amicably.
- Further, we have no objection to the appointment of an Administrator to conduct the elections if any appointed as per law. However, approaching the Hon'ble Court by DRRC at this stage does not appear to be a prudent step. We also seek clarity on how the Administrator will conduct elections for the branches and Headquarter alongwith the expected expenditure. Therefore, before approaching the Hon'ble Court, it would be appropriate to examine all aspects

of the issue in detail and discuss in council meeting. Further, it will be in the interest of all concerned members that opposing parties should sit together again and amicably settle all ongoing election-related disputes so that the election process can be initiated.

4. It is pertinent to mention here that inspite of the undersigned and Hony. General Secretary Sh. Sandeep Srivastava repeatedly requested you to refrain from taking such drastic action and assured that after the matter discussed in HQ office Bearers meeting held on 16th January 2026, it was decided unanimously that everybody should wait upto 30th January 2026 (Court cases hearing date on various matters) and after getting the outcome of case listed. The HQ office Bearers will again have a meeting and decide about conducting the Council meeting as suggested by the DRRC through decision taken on 28th Dec 2025 in the DRRC meeting held without quorum.

5. It is pertinent to mention here that already hard earned money of Members of Association paid towards Advocate's fees to defend the HQ MES BAI (No single case was filed by the HQ MES BAI, only this huge amount paid towards Mediator appointed by the Hon'ble Delhi High court (Rs 4,00,000/- paid to the mediator & Rs 1,00,000/- towards Advocate's fees). Further, in the matter of M/ s Surjit Singh and Sons & Ors vs M.E.S. Builders of India & Ors, which was due to the DRRC meeting which had attracted the Contempt of Court.

6. It is Further stated that the DRRC is a sub-committee of HQ governed under the Council as per Article No 10(b)(vi) of Memorandum and Articles of Association of M E S BUILDERS ASSOCIATION OF INDIA (REGD), any expenses created towards likely Court case you are so adamant to file for Appointment of Administrator for Association which is very unfortunate and same also needs to be approved by the Council . The HQ will not entertain any Expenses / Bills towards your unilateral action based on your personal agenda since same is to be approved from Council prior to any commitment as the case is being filled by you as chairman of DRRC.

7. It is also placed on record that mediation and amicable settlement talks are always welcome at the Headquarter Office of MES BAI, Nehru Place, New Delhi, subject to participation of all stakeholders concerned. You are advised to take a constructive initiative to bring all concerned parties to the same table, so that a common consensus may be evolved to resolve the prevailing issues and to facilitate conduct of elections strictly in accordance with the Memorandum of Association and Rules (MoA & Rules).

8. In view of the above, the undersigned advises you to act strictly within the framework of the Constitution of the Association, i.e., the Memorandum and Articles of Association of M.E.S. Builders Association of India (Regd.), and to extend cooperation to enable the HQ Office Bearers to get election of HQ conducted and in the larger interest of the contractor fraternity, instead of creating further impediments through unwarranted litigation for which HQ is already bearing expenses.
