Subject: REPRESENTATION FOR CONDONATION OF DELAY AND EXTENSION OF TIME FOR SUBMISSION OF RENEWAL APPLICATIONS - ENLISTMENT OF CONTRACTORS IN TERMS OF E-IN-C'S POLICY DATED 11.03.2025 FOR CYCLIC PERIOD 2025-2032.

Respected Sir,

1. The present representation is being made for contractors who have been removed from enlistment due to delay in submission of applications for renewal of enlistment of certain contractors under the Military Engineer Services (MES) for the cyclic period ending 2025-2032. This is to bring to your notice that a number of contractors whose enlistment was due for renewal were unable to apply for the renewal within the cut off as provided under the policy and extended vide HQ letter dated 10.11.2025 issued by your office. The last date extended as per this letter for application of renewal 30.11.2025.

2. This is to bring to your notice that various contractors' application of renewal has been dismissed solely on account of delay in applying or submission of documents which has resulted in the removal of such contractors from the MES enlisted category of Contractors. The contractors could not submit their renewal applications within the prescribed period. Furthermore, no show cause notice was issued to alert the contractors regarding the consequences of non-submission of renewal applications within the stipulated time. In the absence of any such notice, several contractors became aware of the requirement of renewal only at expiry of time stipulated and extended time for renewal and that too through informal communication from other contractors. This situation created considerable confusion and uncertainty among the contractors regarding the applicable timelines and procedures for renewal.

3. It is pertinent to note that during the previous cycle of renewal for the period 2020-2025, contractors were adequately informed through proper notices issued by the authorities. Those notices were circulated in advance, enabling contractors to submit their renewal applications within the stipulated timeframe. However, in the present cycle, the extension of time for submission of renewal applications was neither uniformly nor widely circulated among all enlisted contractors. There was a clear lack of clarity and dissemination of information, leading to inconsistent awareness among contractors across different formations and regions.

4. It is respectfully submitted where the rights, professional opportunities and livelihood of contractors across the country are affected. The removal of contractors from the enlistment system, despite there being no issue of misconduct, disciplinary action, or adverse findings against them, results in extremely serious consequences. Such removal deprives contractors of the opportunity to participate in MES tenders and undertake works under the organisation, thereby affecting their livelihood and professional existence. Furthermore, such exclusion operates in a manner similar to permanent blacklisting, which is impermissible under law, as the removal order effectively causes civil death of the contractor.

5. It is therefore most respectfully requested that your good office may kindly consider condoning the delay in submission of renewal applications in cases where the applications were submitted after the prescribed deadline, including the extended timeline. It is further requested that the competent authority may kindly issue an appropriate notice or direction extending the time for submission of renewal applications or permitting consideration of delayed applications as a one-time measure, subject to verification of eligibility and compliance with renewal requirements.

6. It is also respectfully submitted that in the interest of equity, transparency and in order to protect the legitimate interests of genuine contractors associated with MES, it is earnestly requested that those contractors who have not yet submitted their applications for renewal of enlistment or those who have submitted the same belatedly and consequently their names have been removed from the approved list of enlisted contractors, may kindly be granted a compassionate consideration.

It is further prayed that Show Cause Notices may kindly be issued to such contractors, affording them a fair and reasonable opportunity to submit their renewal applications within a one-time stipulated extended period to be notified by the competent authority. This magnanimous measure would uphold the principles of
