Dear,

This is to intimate you that in the Council meeting held at New Delhi on 15 April 2015, the Election Commission has been formed to conduct the election of all the branches and HQ of our Association. It has also been decided that in accordance to our bylaw branch election has to be completed by 31<sup>st</sup> May 2015 and based on the branch elections HQ elections will be held by 30<sup>th</sup> June 2015.

Therefore as the Chief Election Commissioner I hereby request you to take necessary measure to conduct the election of your branch by 31<sup>st</sup> May 2015 positively as per the provision of the Memorandum and Article of Association of MES Builders Association of India (Regd.). In this regard please refer para 10 sub para (a) to (h) in page 13 to 20 of the Memorandum and Article of Association of MES Builders Association of India (Regd.) amended up to 26.07.2013.

Kindly note that if your Branch failed to conduct the election by 31<sup>st</sup> May 2015 for whatsoever the reason it may be or did not communicate the result of such election by 05 June 2015 to the Election Commission of MESBAI, your branch will automatically be debarred to participate in the HQ election. This provision of our bylaws is not negotiable.

For your guidance the important provisions to conduct the Branch Election are listed in the attached sheet. For any clarification please feel free to contact the undersigned, or the Election unit at the HQ.

## IMPORTANT POINTS FOR CONDUCTING BRANCH ELECTION

- Hony. Secretary of the branch will convene the executive committee meeting of the branch to elect/select election chairman of the branch from any member of the branch and also to fix the date, time and venue of the branch election as per decision of the executive committee.
- The date of election should be after the date of publishing of valid list of members by the Election Commission i.e 05 May 2015 and on or before 31<sup>st</sup> May 2015. If any branch holds their Election before or after the scheduled date, such election will be considered invalid and the Council member of such branch will not be eligible to take part/vote in HQ Election.
- The minutes of such Executive committee meeting along with the clear 21 days notice of Election, mentioning the date, time and venue of the branch election signed by the branch election chairman, has to be reached to the election commission at HQ and Vice Presidents of respective region within a week of such meeting.
- There must be a gap of clear 21 (Twenty One) days between the date of signing the Election Notice and the date of Election.
- The Valid membership list of the branch based on the HQ record as on 31 March 2015 uploaded on the Website by 5<sup>th</sup> May 2015 and the members who have cleared all dues (i.e HQ share of subscription for the year 2015-2016 and any other dues towards the HQ) before date of Election of Branch will be considered as valid voter.
- The branches must remit HQ share of Subscription & other dues if any to HQ latest by 20<sup>th</sup> June 2015.
- Any decision of the Election Commission regarding Election matter of the branch is final and binding for the time being. However it could be challenged in the DRRC and be reviewed by the DRRC only after the complete Election process is over (Including the HQ Election)
- The above is unanimous decision of the Election Commission.
